- Tests for gas leaking on sealing surface towards GIS (Helium leakage test): 100% tested; limits acc. IEC 60137 clause 9.8

Roughness of inner surface dry type: <N7 (Ra=1.6µm; RT=12.5µm; RZ=10µm)
Roughness of flange sealing surface: <N7
